INITIAL INSPECTION

You should always inspect the shipping carton for damages or possible shortages as soon as you receive your unit. If there are any signs of possible shipping damages, unpack the units and make a note of the shortage or damage on the freight bill before signing it. If the carton is opened at a later time and there is damage to the unit, you should file a concealed damage claim with the delivery carrier. They are responsible for any damages in shipment or shortages that were actually shipped.

LIMITED LIFETIME WARRANTY - WHAT IS COVERED BY THIS WARRANTY?

IMPORTANT: AIRBOX Air Purifier warrants that if you—our customer—purchase one of our products, and we determine that it is defective in material and/or workmanship during your lifetime (for commercial customers, a lifetime is equivalent to 5 years), we will repair or replace it at no charge. Fan Motors are warranted for 5 **years** from the date of purchase. AIRBOX Air Purifier's published guidelines include, but are not limited to, information contained in technical specifications, user manuals, and service communications.

Should you need a replacement product, AIRBOX Air Purifier reserves the right to replace an obsolete product with a current production, like model. In the event that any issue with an AIRBOX Air Purifier product is not covered under this warranty AIRBOX Air Purifier can arrange to have the product repaired for a reasonable fee.

Any part which is determined to be defective in material or workmanship and returned to AIRBOX Air Purifier or authorized service facility, as AIRBOX Air Purifier designates, shipping cost prepaid, will be, as the exclusive remedy, repaired or replaced, at AIRBOX Air Purifier option. Any liability for consequential and incidental damage is expressly disclaimed. AIRBOX Air Purifier liability, in all events, is limited to and shall not exceed, the purchase price paid. Title and risk of loss pass to buyer on delivery to the common carrier. If product is damaged in transit, recipient must file claim with carrier. AIRBOX Air Purifier will make a good faith effort for prompt correction or other adjustments with respect to any product that proves to be defective within the warranty period.

LIMITED LIFETIME WARRANTY - WHAT IS *NOT* COVERED BY THIS WARRANTY?

This warranty **does not cover** consumables or normal wear-and-tear or damage resulting from abuse, alterations, unauthorized repairs, or use contrary to the Product's intended purpose. Additionally, this Warranty does not apply: (a) to replacement filters (b) to cosmetic damage, including, but not limited to, scratches, dents, and broken plastic, unless such damage has occurred due to a defect in materials or workmanship; (c) to damage caused by use with a third party component or product, including without limitation any replacement air filters not manufactured by AIRBOX Air Purifier; (d) to damage caused by breakdowns, fluctuations, or interruptions in electric power or by connection to improper power supply; (e) to damage caused by accident, abuse, misuse, fire, liquid contact, earthquake, or other external force; (f) to damage caused by operating the AIRBOX Air Purifier product outside AIRBOX Air Purifier's published guidelines; (g) to damage caused by service performed by anyone who is not a representative of AIRBOX Air Purifier; (i) to a AIRBOX Air Purifier product that has been modified to alter functionality or capability without the written permission of AIRBOX Air Purifier; (h) to defects caused by normal wear and tear or otherwise due to the normal aging of the AIRBOX Air Purifier product; (j) if any serial number has been removed or defaced from the AIRBOX Air Purifier product; or (m) if AIRBOX Air Purifier receives information from relevant public authorities that a AIRBOX Air Purifier product has been stolen.

YOUR RESPONSIBILITIES

AIRBOX Air Purifier tries to honor this warranty in all cases where it has information regarding your purchase; however, AIRBOX Air Purifier reserves the right not to honor this warranty if it has not been registered within ninety (90) days of your purchase of the AIRBOX Air Purifier

product. Accordingly, we encourage you to complete the warranty registration form online at www.airboxairpurifier.com/warranty or mail in the attached warranty card. This warranty extends only to the original purchasers who acquire new products from AIRBOX Air Purifier or its authorized resellers, or to anyone who receives an AIRBOX Air Purifier product as a gift, provided we are able to verify who made the purchase. Before receiving warranty service, AIRBOX Air Purifier or its agents may require that you furnish proof of purchase details, respond to questions designed to assist with diagnosing potential issues, and follow AIRBOX Air Purifier procedures for obtaining warranty service.

WARRANTY SERVICE DURING THE FIRST 90 DAYS

To submit a claim under this warranty, please contact AIRBOX Air Purifier at 855-927-1386 or by email at info@airboxairpurifier.com. If you submit a valid claim to AIRBOX Air Purifier in accordance with this warranty within ninety (90) days of your purchase of an AIRBOX Air Purifier product, AIRBOX Air Purifier will replace the AIRBOX Air Purifier product with the same model (or with your consent an AIRBOX Air Purifier product that has similar functionality). For warranty claims within the first ninety (90) days, AIRBOX Air Purifier offers free shipping both ways within the forty-eight (48) contiguous United States, and free shipping one way to Canada, Hawaii, Alaska, Puerto Rico, Guam, the Virgin Islands, and APO, FPO or DPO addresses (you pay for shipping to AIRBOX Air Purifier, and we pay for shipping the replacement back to you). By registering your product and purchase information, we can confirm the date of purchase to secure your warranty. Please complete and return this registration card within 90 days from purchase in order to receive our Limited Lifetime Warranty.

WARRANTY SERVICE AFTER THE FIRST 90 DAYS

If you submit a valid claim to AIRBOX Air Purifier in accordance with this warranty after ninety (90) days, but during the Warranty Period, AIRBOX Air Purifier's obligation and liability under this limited warranty is limited to repairing (or, at the sole discretion of AIRBOX Air Purifier, replacing) the AIRBOX Air Purifier product, if in need of repair or deemed defective. When an AIRBOX Air Purifier product or part is replaced, any replacement item becomes your property and the replaced or refunded item becomes AIRBOX Air Purifier's property. To obtain service under this warranty, please contact AIRBOX Air Purifier at the phone number or e-mail listed above. An AIRBOX Air Purifier representative will help determine whether your AIRBOX Air Purifier product requires service or needs replacing and, if it does, will inform you how AIRBOX Air Purifier will provide such service or replacement. In such cases, AIRBOX Air Purifier may, at its sole discretion, offer free shipping both ways within the forty-eight (48) contiguous United States, or free shipping one way to Canada, Hawaii, and Alaska (you pay for shipping to AIRBOX Air Purifier, and we pay for shipping the repaired or replaced product back to you). Please note that any repairs attempted or completed without AIRBOX Air Purifier authorization will void this warranty. AIRBOX Air Purifier reserves the right to change the method by which AIRBOX Air Purifier may provide warranty service to you, and your AIRBOX Air Purifier product's eligibility to receive a particular method of service. Service will be limited to the options available in the country where service is requested. Service options, parts availability, and response times may vary according to country. If you seek service in a country that is not the original country of purchase, you will comply with all applicable import and export laws and regulations and be responsible for all custom duties, V.A.T. and other associated taxes and charges.

LIMITATION OF LIABILITY

SUBJECT TO THE FOREGOING, IN NO EVENT WILL AIRBOX AIR PURIFIER BE LIABLE FOR ANY DAMAGES IN EXCESS OF THE FEES PAID BY YOU IN CONNECTION WITH YOUR USE OF THE SERVICES DURING THE SIX MONTH PERIOD PRECEDING THE DATE ON WHICH THE CLAIM AROSE.

BINDING ARBITRATION AND CLASS ACTION WAIVER

In the event of a dispute, you agree to binding individual arbitration before the American Arbitration Association ("AAA") under the Federal Arbitration Act, and agree not to sue in court in front of a judge or jury. Class action lawsuits, class-wide arbitrations, private attorney-general actions, and any other proceeding where someone acts in a representative capacity are not allowed, nor is combining individual proceedings without the consent of all parties. The term "dispute" is to be construed broadly, and includes any claim or controversy between you and us concerning the Services or these Terms, under any legal theory including contract, warranty, tort, statute, or regulation.

If you have a dispute, send a Notice of Dispute by U.S. Mail to: Austin Air Box LLC 2216 Ranch Road 620N, Austin, Texas 78734, including your name, address, how to contact you, what the problem is, and what you want. After 60 days, you (or we) may start an arbitration if the dispute remains unresolved. You must file any claim or dispute within one year from when it first could be filed. Otherwise, it's permanently barred. These Terms govern to the extent they conflict with the AAA's Commercial Arbitration Rules or Consumer Arbitration Rules. If the class action waiver is found to be illegal or unenforceable as to all or some parts of a dispute, then those parts will not be arbitrated but will proceed in court, with the rest proceeding in arbitration.

GENERAL

No AIRBOX Air Purifier reseller, agent, or employee is authorized to make any modification, extension, or addition to this Warranty. If any term is held to be illegal or unenforceable, the legality or enforceability of the remaining terms shall not be affected or impaired. This Warranty is governed by and construed under the laws of the State of Texas, and you hereby consent to the exclusive jurisdiction of the state courts in Travis County, Texas. AIRBOX Air Purifier or its successor in title is the warrantor under this Warranty. Any future claims regarding your AIRBOX Air Purifier product are governed by this Warranty. However, AIRBOX Air Purifier reserves the right, as a general matter, to change its warranty policies. If you make any future purchases of AIRBOX Air Purifier products, those products may be governed by different warranty policies.
